ORDINANCE**

**AN ORDINANCE OF THE CITY OF SWEETWATER, TEXAS ORDERING A MUNICIPAL ELECTION TO BE HELD ON MAY 1, 2021, FOR THE PURPOSE OF ELECTING A MAYOR AND TWO (2) CITY COUNCILMEMBERS OF SAID CITY; AND PROVIDING DETAILS RELATING TO THE HOLDING OF SUCH ELECTION.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF SWEETWATER, TEXAS, that:**

**Section 1.** In accordance with the Charter of the City of Sweetwater and with the laws of the Constitution of the State of Texas, an election is hereby called and ordered to be held between the hours of seven (7:00) o'clock a.m. and seven (7:00) o'clock p.m. on the 1<sup>st</sup> day of May 2021 at which election all qualified voters of the City may vote for the purpose of electing the following officials of the City, each for a two-year term:

Mayor, at-large  
Councilmember, Precinct 1  
Councilmember, Precinct 3

**Section 2.** No person's name shall be placed upon the official ballot as a candidate for any of the above-mentioned positions unless such person shall have filed his or her sworn application, as provided by the laws of the State of Texas, with the City Secretary of the City at the City Hall, located at 200 East Fourth Street, Sweetwater, Texas 79556, beginning on January 13, 2021 and not later than five o'clock (5:00) p.m. on February 12, 2021. The City Secretary shall note on the face of each such application the date and time of its filing. Such application shall include the position the candidate is seeking.

**Section 3.** The name of each candidate shall be placed on the respective ballots under the conditions imposed by law and that the candidate or candidates receiving the votes necessary for election shall be elected to the office for which each candidate has announced. The determination of successful candidates shall be in accordance with the provisions of the Charter of the City of Sweetwater, Texas and the Election Code of the State of Texas, Revised.

**Section 4.** The City Secretary shall be the Early Voting Clerk and shall secure early voting ballots and shall conduct voting by personal appearance and by mail as contemplated by Sec. 85.001 and Sec. 85.005(d) of the Election Code of the State of Texas. City Hall, 200 East Fourth Street, is hereby designated as the Early Voting Site for early voting for the election. During the lawful early voting period the Early Voting Clerk shall keep such place for early voting open for early voting from 8:00 a.m. – 5:00 p.m., Monday through Friday, April 19, 2021 – April 27, 2021; and from 7:00 a.m. – 7:00 p.m. on Tuesday April 20, 2021 and Tuesday, April 27, 2021


**Section 5.** This Ordinance shall take effect immediately from and after its passage, as law provides. The Mayor is authorized to sign a Notice of Regular Municipal Election (Exhibit A) and an Order of Election (Exhibit B) as prescribed by the State of Texas on behalf of the City Council. The Notice of Regular Municipal Election shall be published in accordance with the provisions of the Texas Election Code. Being that said notice be posted upon the bulletin board of the City Hall of the City of Sweetwater, Texas for a period of at least twenty (20) days before the election and by publishing such notice at least one (1) time, not earlier than the 30<sup>th</sup> day or later than the 10<sup>th</sup> day before the election day, in at least one (1) daily newspaper published in the City of Sweetwater, Texas. The secretary shall make a return on the posted copy of the notice showing how and when he executed such notice and such return copy shall be retained in the files of the City Secretary of the City of Sweetwater, Texas.






