- 2. Loren Rule with Emmanuel Fellowship Church gave the invocation.
- 3. Police Chief Bryan Sheridan led the Pledge of Allegiance to the American and the Texas Flags.
- 4. Motion was made by Councilman Castro, seconded by Councilman McPherson to approve the minutes for meeting held on August 9, 2022. The motion carried unanimously.

B. Motion was made by Councilman Baker, seconded by Councilman McPherson to approve a Resolution reviewing and approving the Investment Policy for Fiscal Year 2023. The motion carried unanimously.

### A RESOLUTION REVIEWING AND APPROVING THE CITY OF SWEETWATER INVESTMENT POLICY FOR FISCAL YEAR 2023.

C. Motion was made by Councilman Castro, seconded by Councilman McPherson to enter into a public hearing on the FY 2022 – 2023 Proposed Budget for the City of Sweetwater. The motion carried unanimously.

This budget will raise more revenue from property taxes than last year's budget by an amount of \$51,725 which is a 1.89 percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$7,663.

There were no public comments.

Motion was made by Councilman Castro, seconded by Councilman Baker to close the public hearing and enter into regular session. The motion carried unanimously. No action was necessary.

D. Motion was made by Councilman Castro, seconded by Councilman McPherson to enter into a public hearing on the Proposed Tax Rate of \$0.5075 (cents) per \$100 valuation for Tax Year 2022. The motion carried unanimously.

This tax rate will raise more taxes for maintenance and operations than last year's tax rate.

The tax rate will effectively be raised by 1.61 percent and will raise taxes from maintenance and operations on a \$100,000 home by approximately negative \$40.50
