- G. Motion was made by Councilman Baker, seconded by Councilman Castro to reappoint Mr. Jeremy Wilks to the Planning and Zoning Commission as a regular member with term expiring October 2024. The motion carried unanimously.
- H. Motion was made by Councilman Castro, seconded by Councilman McPherson to approve reappointments of Ms. Sharmaine Carrington and Ms. Carol Gotcher to the Board of Commissioners for the Sweetwater Housing Authority, for two-year terms. The motion carried unanimously.
