- 1. Mayor McKenzie called the meeting to order.
- 2. Ollie Wilburn with Rhema Valley Family Church gave the invocation.

- 4. Motion was made by Councilman Peek, seconded by Councilman Castro to approve the minutes for the meeting held on May 9, 2023. The motion carried unanimously.

Group Health benefits to be considered at the Council's July 11, 2023 meeting.

C. Council to consider accepting a donation from the Nolan County Foundation to assist with the purchase of park equipment for Newman Park.

- F. Motion was made by Councilman Castro, seconded by Councilman Baker to approve Change Order No. 2 for the meter replacement and AMI contract. The motion carried unanimously.
- G. Motion was made by Councilman Castro, seconded by Mayor Pro Tem McPherson to approve and accept funding from the MDD to assist with the demolition of the burnt structure at 110 Pecan Street. The motion carried unanimously.
- H. Motion was made by Mayor Pro Tem McPherson, seconded by Councilman Castro to accept low bid from AML Environmental for the cleanup of property located at Lots 16, 17 and 18, Block 21, Original Town of Sweetwater, Nolan County, TX and commonly identified as 110 Pecan Street, Sweetwater, Nolan County, Texas. The motion carried unanimously.
- I. Motion was made by Councilman Peek, seconded by Councilman Castro to enter in to a public hearing on proposed tax abatement Guidelines and Criteria. The motion carried unanimously.
