- 1. Mayor McKenzie called the meeting to order.
- 2. Larry Holder with Highland Heights Methodist Church gave the invocation.
- 3. Councilman Castro led the Pledge of Allegiance to the American and the Texas Flags.
- 4. Motion was made by Councilman Castro, seconded by Mayor Pro Tem McPherson to approve the minutes for the meeting held on February 13, 2024. The motion carried unanimously.

- 6. Mr. Ryan Garcia with JES Holdings spoke in regards to Sweetwater Station, a 52 unit development at 1105 East Broadway. Mr. Garcia spoke about the housing taxing credits, development information, resident unit features and community features.

Mr. Mark Mayfield with Texas Housing Foundation spoke in regards to the leadership and goals of the Foundation. They provide services to affordable housing projects through related business entities and for the residents and communities in which they are located.

Creekside Subdivision detention pond to cover interim maintenance until the pond is vegetated and accepted by the City of Sweetwater. The motion carried unanimously.
