## Joint Operation Leads to Multiple Online Solicitation Arrests

Sweetwater, Texas – The Sweetwater Police Department conducted a multi-agency operation aimed to identify and arrest individuals attempting to prey on children in the community.

Federal, state, county and local agencies assisted in the investigation. Participating agencies include US Department of Homeland Security, US Border Patrol, Federal Bureau of Investigation, Texas Department of Public Safety Criminal Investigations Division, Nolan County Sheriff's Office, Sweetwater Fire Department, 32nd Judicial District Attorney's Office Investigators, Howard County Sheriff's Office, Abilene Police Department Cyber Crimes Division and Texas Parks and Wildlife Game Wardens.

During the operation, ten suspects were arrested on charges including Online Solicitation of a Minor, Online Solicitation of Prostitution of Minor, Possession of Controlled Substance, unlawful Carrying of Weapon, Evading Arrest or Detention Using Motor Vehicle and Aggravated Assault Against Public Servant.
