Lynn Barrett, Director of Planning and Operations spoke about the request to rezone property. Staff recommendation was to approve request.

Kate Bennett spoke against the rezoning request. She expressed concerns regarding her family's health from the fumes of the fueling station and their safety from the extra traffic that will occur.

Seth Mahaffey spoke in regards to his company's plans for a fueling station and future use for a mechanical shop at said property.
