
1. Call to order.

4. No Council/Board discussion or action may take place on a matter until such matter has been placed on an agenda and posted in accordance with law - GC, 551.042.]
5. Action Items.
 - A. Ordinance: City Council to discuss, consider and act upon approval of an Ordinance fixing and levying a tax for Tax Year 2019.
 - B. Ordinance: City Council to discuss, consider and act upon approval of Ordinance Amending the Fiscal Year Ending 2018-2019 Budget.
6. Closed Session (Project 2019-003): Called in accordance with Section 551.087 of the Texas Government Code, Deliberation Regarding Economic Development Negotiations; Closed Meeting. The governmental body is not required to conduct an open meeting (1) to discuss or deliberate regarding commercial or financial information that the governmental body has received from a business prospect that the governmental body seeks to have locate, stay, or expand in or near the territory of the governmental body and with which the governmental body is conducting economic development negotiations; or (2) to deliberate the offer of a financial or other incentive to a business prospect.
