- G. Presentation was made by Sage Diller with eHT. Motion was made by Mayor Pro Tem May, seconded by Councilman Lee to approve proposed bid solicitation schedule and a potential date of bid award for the Texas Water Development Board Drinking Water State Revolving Fund (Contract D) project. The motion carried unanimously.
