Motion was made by Commissioner May, seconded by Mayor Pro Tem Peek to approve an Resolution approving a tariff authorizing an annual Rate Review Mechanism ("RRM") as a substitution for the annual interim rate adjustment process defined by Section 104.301 of the Texas Utilities Code, and as negotiated between Atmos Energy Corp., Mid-Tex Division ("Atmos Mid-Tex" or "Company") and the Steering Committee of Cities Served by Atmos; requiring the company to reimburse Cities' reasonable ratemaking expenses; adopting a savings determining that this Resolution was passed in accordance with the requirements of the Open Meetings Act; declaring an effective date; and requiring delivery of this Resolution to the company and legal counsel for the Steering Committee. Shaun Martin with Atmos Energy spoke about the need of tariff, no major rate procedure changes. The motion carried unanimously.
