- 1. Mayor McKenzie called the meeting to order.
- 2. Richard Acuna from Trinity Baptist Church gave the invocation.
- 3. Mayor Pro Tem May led the Pledge of Allegiance to the American and the Texas Flags.
- 4. Motion was made by Mayor Pro Tem May seconded by Commissioner Peek, to approve the minutes for the meeting held on May 8, 2018. The motion carried unanimously.
- 5. Action Items
  - A. Presentation was made by Mr. Stewart J. Chapman, P.E., regarding Texas Department of Transportation Construction project along I-20 access road between BUS70 (Lamar St.) East to E. Arizona Ave. Mayor Pro Tem May expressed his concerns with traffic on Hwy-70/I-20. Project began June 11, 2018 with an estimated completion of early November 2018.
