- 2. Ashley Barnes with Trinity Baptist Church gave the invocation.

- 4. Motion was made by Mayor Pro Tem May, seconded by Commissioner Peek, to approve the minutes for the meeting held on July 10, 2018. The motion carried unanimously.

The proposals were taken by Nancy Johnson with Tommy Morris Agency, Broker of Record to analyze and review. Motion was made by Mayor Pro Tem May, seconded by Commissioner Peek to table until the September 11, 2018 meeting. The motion carried unanimously.
- F. Motion was made by Mayor Pro Tem May, seconded by Commissioner Peek to enter into public hearing on repealing Chapter 4 entitled "Alarm Systems" of the code of ordinances of the City of Sweetwater and adopting a superseding ordinance, Chapter 4 entitled "Alarm Systems." The motion carried unanimously.

Public comments: Randy Wilks with Sierra Security spoke about his business and interest in ordinance. Mark McDonald had question regarding false alarms.

Motion was made by Commissioner Peek, seconded by Mayor Pro Tem May to close public hearing and enter into regular session. The motion carried unanimously.

The motion carried unanimously.
