- 2. Ryan Strebeck gave the invocation.
- 3. Commissioner Lee led the pledge of allegiance.
- 4. Motion was made by Commissioner May, seconded by Commissioner Lee to approve minutes for the meeting held on June 13, 2017. The motion carried unanimously.

5. Action Items:

A. Motion was made by Commissioner Lee, seconded by Commissioner Castro to reconsider bid award to Robert's Construction for the Texas Water Development Board Water Line Replacement project that will replace a 10-inch water line in the vicinity of the new elevated storage tank located at 806 W. Arizona. John Voller with Eht explained contractor's math error, making Robert's Construction the true low bidder. The motion carried unanimously.

Motion was made by Commissioner May, seconded by Commissioner Lee to approve Second and Final Reading of Ordinance denying the proposed change in rates of Oncor Electric Delivery Company LLC, finding and determining that the meeting at which this Ordinance is passed is open to the public as required by law. Kristy Tyra with Oncor spoke about the Oncor acquisition being a positive and stable change for its customers. The motion carried unanimously.

- F. Motion was made by Commissioner May, seconded by Commissioner Lee to authorize staff to receive competitive sealed proposals on Self Insured Group Health, Dental, Life Insurance Benefit to be considered at August 8, 2017 meeting. The motion carried unanimously.

G. Motion was made by Commissioner Lee, seconded by Commissioner Castro to approve Resolution requesting financial assistance from the Texas Department of Transportation (TxDOT) for Design and Construction for Pavement Rehabilitation at Avenger Field Airport; naming TxDOT as the City's agent; and directing the City Manager to execute all contracts and agreements on behalf of the City for such improvements. Kirk Harris, City Services Director explained TxDOT's request. The motion carried unanimously.
