- 1. Mayor McKenzie called the meeting to order.
- 2. Commissioner Lee gave the invocation.
- 3. Commissioner May led the pledge of allegiance.
- 4. Presentation of Leadership Sweetwater
- 5. Motion was made by Commissioner May, seconded by Mayor Pro Tem Peek, to approve the minutes for the meeting held on October 10, 2017. The motion carried unanimously.
- 6. Action Items
 - A. Motion was made by Commissioner Lee, seconded by Mayor Pro Tem Peek to approve second and final reading of an Ordinance closing of an undeveloped alley in Block 3 of J.E. Stallings subdivision to the City of Sweetwater between Canfil Street and Park Avenue (undeveloped) from Bluff Street (undeveloped) west to dead end. The motion carried unanimously.

B. Motion was made by Mayor Pro Tem Peek, seconded by Commissioner May to enter into a public hearing amending Chapter 19, Section 151, entitled "Parking Prohibited Over Parts of Designated Streets" by amending the Hailey Street and Highway 20 Frontage Road/NE Georgia Provisions. The motion carried unanimously.

Motion was made by Commissioner May, seconded by Commissioner Lee to close public hearing and enter into regular session. The motion carried unanimously.

Mayor Pro Tem Peek asked where trucks would park if not able to park on designated streets. David A. Vela, City Manager said they would be able to park in designated parking areas.

Motion was made by Mayor Pro Tem Peek, seconded by Commissioner May to approve first reading of an Ordinance amending Chapter 19, Section 151, entitled "Parking Prohibited Over Parts of Designated Streets" by amending the Hailey Street and Highway 20 Frontage Road/NE Georgia Provisions. C. Presentation was made by Police Chief Brian Frieda on Juvenile Curfew Ordinance. Commissioner Lee asked expressed concern in the difference between expelled and suspended in language of ordinance. Police Chief Brian Frieda explained that a call would be made to school to find out if student was expelled or suspended.

- D. Commissioner May asked what will happen to old ambulance. Fire Chief, Grant Madden said that it could be auctioned or donated to another agency. Motion was made by Mayor Pro Tem Peek, seconded by Commissioner Lee to approve Ambulance purchase. The motion carried unanimously.
- E. Commissioner May made the point that Judges and alternates were to be appointed by Commission before the election. Commission is ratifying after the fact. Motion was made by Commissioner May, seconded by Commissioner Lee to acknowledge the November 7, 2017, Special Election Judges, their Alternates and workers, and the Early Voting Ballot Board. The motion carried unanimously.
- F. Motion was made by Mayor Pro Tem Peek, seconded by Commissioner Lee to approve resolution and order canvassing the returns and declaring the results of the November 7, 2017, Special Election. David A. Vela, City Manager, spoke about the results and the ballot language. The motion carried unanimously.

- H. Presentation was made by Charlie Davis and Ryan Wonder from Schneider Electric on Energy Efficiency and Capital Reinvestment Program. Commissioner May had inquires such as how the savings is quantified, why retrofitting could not be done by City employees and the bidding process. Mayor Pro Tem Peek asked about length of time audit will take. Motion was made by Commissioner Lee, seconded by Mayor Pro Tem Peek to approve Schneider Electric Energy Services Professional Services Investment Grade Audit for the Interlocal Purchasing System (TIPS) Contract #170103. Mayor McKenzie, Mayor Pro Tem Peek and Commissioner Lee voted For, and Commissioner May voted Against.
