- 1. Mayor McKenzie called the meeting to order.
- 2. Kirk Maberry gave the invocation.
- 3. Ricky Castro led the pledge of allegiance.
- 4. Motion was made by Commissioner May, seconded by Mayor Pro Tem Peek to approve minutes for the meeting held on January 10, 2017. The motion carried unanimously.
- 5. Consent Agenda Commissioner May requested that items be moved to individual Action Items.
 - A. Motion was made by Mayor Pro Tem Peek, seconded by Commissioner Castro to approve Ordinance ordering an election of the qualified voters of the City of Sweetwater to be held on May 6, 2017, for the purpose of electing a Mayor and two City Commissioners (Precincts 1 and 3) of said City. The motion carried unanimously.

- B. Motion was made by Commissioner May, seconded by Mayor Pro Tem Peek to reappoint Bill Johnson as the City/County appointee as member of the City/County Joint Airport Zoning Board whose term will expire February 28, 2019. The motion carried unanimously.
- C. Motion was made by Mayor Pro Tem Peek, seconded by Commissioner Lee to reappoint Larry Ludlum as the City appointee to the Nolan County Municipal Auditorium Board whose term will expire February 28, 2019. The motion carried unanimously.
- D. Motion was made by Commissioner Lee, seconded by Commissioner May to authorize staff to advertise for bids on (22) Oak Creek and (5) Lake Sweetwater lots leases for lease hold interest in said lots and to open said bids on April 11, 2017. The motion carried unanimously.
- E. Motion was made by Mayor Pro Tem Peek, seconded by Commissioner May to authorize staff to go out for bids on AC 10 and Grade 4 crushed rock to be used for the 2017 streets seal coating project. The motion carried unanimously.
- F. Motion was made by Mayor Pro Tem Peek, seconded by Commissioner Castro to consider first reading of amending Chapter 18, Article II of the Code of Ordinances of the City of Sweetwater entitled "Curfew for Minors" by adding Paragraph (a) (3) and by amending Section 18-45 entitled "Penalties." Chief Frieda to spoke on necessity of city ordinance. The motion carried unanimously.
- G. Motion was made by Commissioner May, seconded by Mayor Pro Tem Peek to consider first reading of amending Chapter 19, Article IV, entitled "Operation of Vehicles Generally" by adding a new Section 19-12 entitled "Use of Engine Brakes." Chief Frieda spoke on necessity of city ordinance. The motion carried unanimously.
- H. Motion was made by Commissioner Lee, seconded by Commissioner Castro to consider first reading amending Chapter 6, of the Code of Ordinances of the City of Sweetwater entitled "Animals and Fowl" by adding Sections 6-45 entitled "Interference with Traps and Equipment set out by Department of Animal Services"; by adding Section 6-46, "Feeding Stray Cats or Dogs"; and by adding Section 6-47 "Penalty for Violation." Chief Frieda spoke on necessity of city ordinance. The motion carried unanimously.

- D. City Commission heard presentation from Anne Ruthstrom, Texas Rural Water Association, on the City of Sweetwater's new well field Source Water Protection Plan. Motion was made by Mayor Pro Tem Peek, seconded by Commissioner Castro to approve a steering committee responsible for BMP's (best management practices) and outreach efforts. The motion carried unanimously.
- E. Motion was made by Mayor Pro Tem Peek, seconded by Commissioner Lee to authorize the City Manager to utilize PEG funds to fund the purchase of equipment necessary to broadcast City Commission meetings. The motion carried unanimously.
