I have a concern about the the city pool being closed through the Summer. There has been no official announcement about the pool not being open top the public, but I have talk to several people and they had been told no pool for the Summer due to possible shortfall in operating budget caused by the COVID -19 Virus and the Social distancing affecting the Sales Tax revenue.

I can understand the shortage of revenue, What my question is what will the older kids have available to them when restrictions ease and the kids have no where to go. The pool allows kids to burn off energy and have somewhere they can meet their friends. I know that the City spent three-quarters of a million dollars to create the Splash Pad, but it was made for the smaller kids. The bigger kids have no where to go will be at the Splash Pad pushing and shoving the little ones. They could tear up the new equipment which is not made for them to use.

I also talked with the City of Colorado City because they had their pool closed last year. The city secretary told me that they experience a Jump in Juvenile Crime over the Summer last year due to the pool being closed during this Summer, When I mentioned that our Pool would be closed this year, her immediate reaction was "good luck with that" The Kids had too much free unsupervised free time.

Maybe I am uniformed and need more info, but at this time all I see kids with almost 4 months of energy and no safe place to go.
