- 1. Mayor McKenzie called the meeting to order.
- 2. Fire Chief Grant Madden gave the invocation.
- 3. Councilman Castro led the Pledge of Allegiance to the American and the Texas Flags.
- 4. Motion was made by Mayor Pro Tem Peek, seconded by Councilman Castro to approve the minutes for meeting held on May 12, 2020.
- 5. Public Input:

Patty Soules expressed her concerns over illegal gaming rooms. She is a hometown business owner and is in financial distress due to illegal activity of other game rooms in town. She feels her business is harmed by the lack of action against illegal game rooms.

Carolyn Mullican spoke in support of her sister, Patty Soules' game room. She asked for help with the illegal game rooms in town and feels our ordinance is hurting the game rooms that are trying to do everything legal.

- 6. Regular Agenda Items
 - A. Motion was made by Mayor Pro Tem Peek, seconded by Councilman Castro to accept resignation of Councilman Grant Cherry. The motion carried unanimously.
 - B. Motion was made by Mayor Pro Tem Peek, seconded by Councilman Castro to enter into closed session at 9:55 a.m. in accordance with Section 551.074 of the Texas Government Code, the City Council will meet in closed session to discuss and deliberate the appointment of a public officer; to wit: Filling vacancy for unexpired term for City Council Member, District 1, which expires May 2021. The motion carried unanimously.
 - C. Motion was made by Mayor Pro Tem Peek, seconded by Councilman Castro to reconvene into regular session at 9:57 a.m. The motion carried unanimously.
 - D. Motion was made by Councilman Castro, seconded by Mayor Pro Tem Peek to appoint Larry May as candidate to fill the vacancy for unexpired term for City Council Member, District 1, which expires May 2021. The motion carried unanimously.
 - E. Motion was made by Mayor Pro Tem Peek, seconded by Councilman Castro to authorize City staff to receive bids for Oak Creek Lake lots #468 and #509 which were returned to the City for non-payment of the annual lake lease. The motion carried unanimously.
 - F. Motion was made by Mayor Pro Tem Peek, seconded by Councilman Castro to appointment of Mr. Gil Cherry, who is currently serving as alternate member, to a regular member; and appointment of Mr. Jeremy Wilks as an alternate member for the Planning and Zoning Commission. The motion carried unanimously.
 - G. Sage Diller with Enprotec/Hibbs & Todd discussed the process for closeout with Texas Water Development Board and made a recommendation to the City for acceptance of the project and release of retainage funds contingent upon funding agency concurrence

Motion was made by Councilman Castro, seconded by Mayor Pro Tem Peek to approve final acceptance of the elevated storage tank (EST) project completed by Landmark Structures, contingent upon funding agency approval. The motion carried unanimously. H. Motion was made by Mayor Pro Tem Peek, seconded by Councilman Baker to approve a Resolution accepting Sweetwater Enterprise for Economic Development – Municipal Development District's donation of park improvements to the City of Sweetwater. The motion carried unanimously.
