- 1. Mayor McKenzie called the meeting to order.
- 2. Councilman May gave the invocation.
- 3. Councilman Castro led the Pledge of Allegiance to the American and the Texas Flags.
- 4. Motion was made by Councilman May, seconded by Mayor Pro Tem Peek to approve the minutes for meeting held on August 18, 2020.
- 5. Public Input: None
- 6. Regular Agenda Items
  - A. Nancy Johnson spoke about recommendations for group health insurance employee benefits.
     Motion was made by Councilman May, seconded by Mayor Pro Tem Peek to stay with BlueCross BlueShield but unbundle reinsurance with HM. The motion carried unanimously.
  - B. Motion was made by Mayor Pro Tem Peek, seconded by Councilman Baker to approve Resolution reviewing and approving the Financial Policy for Fiscal Year 2021. The motion carried unanimously.

#### A RESOLUTION APPROVING THE CITY OF SWEETWATER FINANCIAL POLICY FOR FISCAL YEAR 2021.

C. Motion was made by Councilman May, seconded by Councilman Castro to approve Resolution reviewing and approving the Investment Policy for Fiscal Year 2021. The motion carried unanimously.

#### A RESOLUTION REVIEWING AND APPROVING THE CITY OF SWEETWATER INVESTMENT POLICY FOR FISCAL YEAR 2021.

D. Motion was made by Mayor Pro Tem Peek, seconded by Councilman Castro to enter into a public hearing on the FY 2020 – 2021 Proposed Budget for the City of Sweetwater. The motion carried unanimously.

This budget will raise more revenue from property taxes than last year's budget by an amount of \$129,328 which is a 5.14 percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$6,330.

There were no public comments.

Motion was made by Mayor Pro Tem Peek, seconded by Councilman May to close the public hearing and enter into regular session. The motion carried unanimously. No action was necessary.

E. Motion was made by Councilman May, seconded by Councilman Castro to enter into the first public hearing on the Proposed Tax Rate of \$0.544 (cents) per \$100 valuation for Tax Year 2020. The motion carried unanimously.

This tax rate will raise more taxes for maintenance and operations than last year's tax rate.

The tax rate will effectively be raised by 5.20 percent and will raise taxes from maintenance and operations on a \$100,000 home by approximately \$26.89.
