- 1. Mayor McKenzie called the meeting to order.
- 2. Ollie Wilbourn gave the invocation.
- 3. Councilman Baker led the Pledge of Allegiance to the American and the Texas Flags.
- 4. Motion was made by Councilman Baker, seconded by Councilman McPherson to approve the minutes for meeting held on July 13, 2021. The motion carried unanimously.

- 6. Chief of Police Bryan Sheridan was recognized and presented the Sweetwater Reporter "Readers' Choice Awards" for Best City Employee.
- 7. Regular Agenda Items
 - A. City Council received insurance bids from Blue Cross Blue Shield Health with Stop/Loss, HM Life Stop/Loss Proposal, TML Group Health, Dental and Vision, Metlife Group Benefit, Dental and Vision, Ameritas Dental and Vision and Omaha Dental and Vision and gave them to Broker of Record, Nancy Johnson with Tommy Morris Agency to review. Nancy Johnson will present recommendation to the Council at the September 14, 2021 meeting.
