## **Most Common Fire Code Violations**

- 1. ADDRESS MUST BE CLEARLY VISIBLE FROM THE ROAD WITH 5"-6" NUMBERS WITH CONTRASTING COLORS TO THE BUILDING
- 2. EXIT SIGNS MUST BE INSTALLED OVER ALL EXIT DOORS, HARD WIRED WITH BATTERY BACKUP. (MOST COMMON PROBLEM BURNED OUT BULBS)
- 3. EMERGENCY EXIT LIGHTING MUST BE HARD WIRED AND PROVIDE SUFFICIENT LIGHTING TO ILLUMINATE EXIT ACCESS. (MOST COMMON PROBLEM BURNED OUT BULBS AND DISCHARGED BATTERIES)
- 4. FIRE EXTINGUISHERS MUST BE MOUNTED IN CLEAR VIEW AND EASILY ACCESSIBLE. MUST BE SERVICED ANNUALLY AND TAGGED (MOST COMMON PROBLEM PAST DUE INSPECTION)
- 5. ELECTRICAL PANELS AND HEAT PRODUCING APPLIANCES MUST HAVE 36" CLEARANCE OF STORAGE
- 6. GENERAL HOUSE KEEPING MUST BE NEAT AND ORDERLY (MOST COMMON PROBLEM PRODUCT BLOCKING EXIT DOORS AND AISLE WAYS)
- 7. DUMPSTERS MUST BE MINIMUM OF 5' AWAY FROM BUILDING
- 8. COMPRESSED GAS CYLINDERS MUST BE CHAINED IN PLACE
- 9. ELECTRICAL JUNCTION BOXES MUST HAVE PROPER COVERS IN PLACE
- 10. COMMERCIAL KITCHEN APPLIANCES INCLUDING HOOD AND DUCT SYSTEM MUST REMAIN FREE OF GREASE ACCUMULATION
- 11.COMMERCIAL KITCHEN SUPPRESSION SYSTEMS MUST BE INSPECTED EVERY 6 MONTHS AND TAGGED
- 12.PENETRATIONS IN WALLS AND CEILING MUST BE REPAIRED (MOST COMMON PROBLEMS ARE MISSING CEILING TILES AND HOLES IN STRUCTURAL MEMBERS FOR CABLE OR WIRING)
